A Happy New Year to everyone. How many made it up to midnight on December 31st?

As this new year begins, we are beginning to execute the recommendations of our Clean Water Committee while the Bylaws/Covenants Committee continues their work.

The contracts have been signed for the launch and pier project. The launch will be wider, longer, and deeper. We have contracted with a company to harvest weeds next year with a plan to only spray the small patches of evasive species.




We plan to have the proposed changes to the Bylaws and Covenants distributed to everyone in March. We will have an informational meeting regarding the proposed changes for residents in late April prior to the vote scheduled in late May.


One of the proposed changes to the Bylaws supported by the Board will allow for wider representation of our residents. The first is to limit the time an individual can serve on the Board to 2 full terms of 3 years each, with a maximum of 8 years total. The 8 years allows for someone that is appointed to serve an unfinished term to still serve two additional full terms. The Term Limit change reflects the structures of most HOA boards.


I am bringing this to your attention because it is the time of the year we ask for resumes for two board positions and positions on the Architectural Committee. The board meets once a month from April to October. For those individuals that are interested but attending meetings in person may be difficult, we have the capability of hosting Zoom meetings.

This is our lake, our little piece of paradise. We need people to step up and participate in managing the lake and lake activities.
